

# Privacy Policy

## Description

The Motley Fool Canada, ULC, ("The Motley Fool") takes the issue of privacy very seriously and is committed to protecting and respecting your privacy. This Privacy Policy describes how we may collect, use and disclose personal information of our users, readers and subscribers. It does not apply to personal information that we collect, use or disclose for journalistic purposes.

Submitting your personal information, subscribing to our services or products or using our website, signifies your agreement to the terms and conditions of this Privacy Policy.

## The Information We Collect

- **Email Address:** When you register with The Motley Fool, subscribe to our products and services, or sign up to receive a special report, we ask for your email address. We usually also capture your Internet Protocol address ("IP address") at the time you register.
- **Information We Automatically Track:** While on Fool.ca, we automatically log certain information about how you're using our site. This information may include the URL that you just came from, your IP address and the pages you visit while on our site. The Motley Fool may place a pixel on pages on our site, or those of other companies that are presenting advertisements. This enables us to record in our server logs that a specific user id has visited a particular page. This data allows us to analyse and determine our audience's behavioural characteristics, which helps us to optimise our site and marketing focus. Only anonymous information is collected, and it cannot, by itself or in combination, be tracked to you or any specific individual.

## Where Your Information is Processed and Stored

The information outlined above is processed and stored in the United States. As a result, your information may be subject to US law and jurisdiction. You acknowledge that you will be sending your personal information (including your email address) to computer networks located in the United States and you consent to this transfer. The Motley Fool takes steps to ensure that your information is treated securely and in accordance with this Privacy Policy and applicable law.

## Our Use of this Information

- **More Customised Service:** The Motley Fool collects personal information to provide you with the best and most personalised web experience possible. In short, by knowing a little about you, The Motley Fool can deliver more relevant content to you while at our web site and thus, provide you with a more efficient, customise and seamless experience when using our service.
- **Internal Research:** Cookies and the other information we automatically track are used to help us better understand how our audience uses our site as well as for internal research on users'

demographics and interests. Each browser accessing The Motley Fool is given a unique cookie which is then used to determine usage patterns, and to help in targeting content based on user interests.

- **To Contact You:** We may subsequently email you about our various products and services, or other products and services we feel may interest you.

## **Our Use of IP Addresses and Cookies**

**IP Addresses:** Your web browser or email application automatically provides your IP address to other computers with which you communicate over the internet, so that they know where to send you information. We receive an IP address each time you view one of our web pages, because the browser automatically reports it to us. We also may store the IP address when you register with The Motley Fool.

We may use IP addresses for various purposes, including:

- Diagnosing service or technology problems.
- Assessing and maintaining system security.
- Displaying the most appropriate advertising and content.
- Studying how people use our site and how we can improve it.
- Reporting to advertiser and other business partners about aggregate, but not individual information derived from IP addresses.

**Cookies:** If your browser is set up to accept them, we also use a feature known as a cookie. Cookies contain bits of information that web sites transfer to your computer's hard drive for record keeping purposes. Cookies can make the web more useful by storing information about your preferences on a particular site such as ours.

At The Motley Fool cookies are used in the following ways:

- To automatically access your previously stored account information.
- To estimate our audience size and usage patterns.

You can configure your browser to refuse cookies or to notify you when you've received one. If you reject cookies, though, you may not be able to use portions of our site.

## **Information Sharing and Disclosure**

With the few exceptions that we explain below, The Motley Fool does not give, rent, lend, or sell individual information to any third party. We may, however, provide aggregate information to current and potential business partners. We will disclose personal information only in the following circumstances:

- We may employ the services of third party providers to aid us in certain aspects of our operations (such as the distribution of our email products or conducting a survey for us).
